### Internet Security Tips of the Month:

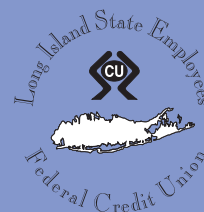
Never give credit/debit card information out when you receive a telephone call. Legitimate companies don't call asking for a credit or debit card account information over the telephone.

If questions arise concerning a credit or debit card account, call the customer service number on the back of the card. This is known to be a legitimate number.

Never respond to emails that request credit or debit card information, and don't respond to emails to verify personal information.

Be cautious and skeptical of anyone that asks for personal or financial information.
