MISSION STATEMENT

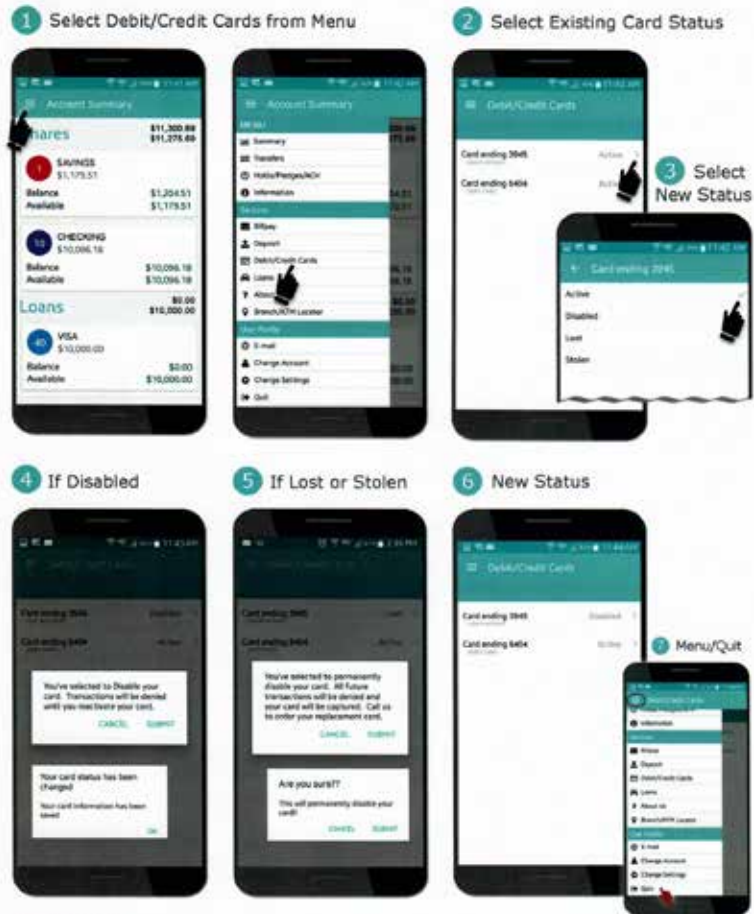

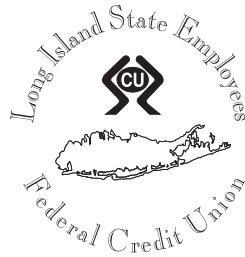

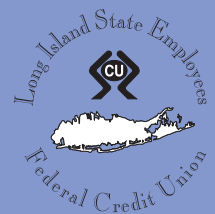
