There will be NO nominations from the floor and no proxy or absentee voting. Three people are up for re-election for the Board of Directors. One person is up for re-election for the Credit Committee.

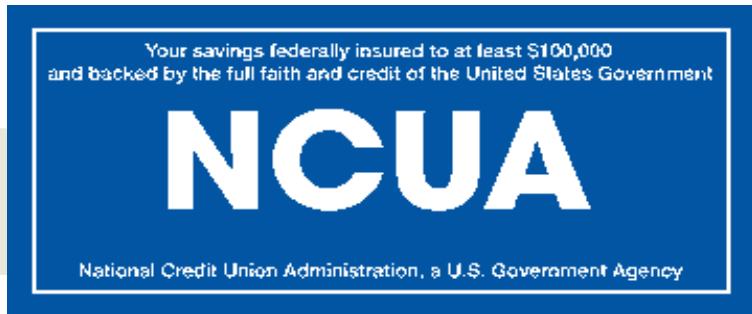

Share Insurance Rises to Protect Your

Passage of the Emergency Economic Stabilization Act. Of 2008 increases NCUA coverage from \$100,000 to \$250,000.

The increase is temporary, taking effect from October 3, 2008 until December 31, 2009. Funds may be insured for even more than \$250,000, depending on how you establish your accounts.
