A Few Words in regards to Equifax data breach

What happened?

Equifax on Sept. 7 announced the cybersecurity incident, one of the largest in history. Unauthorized data access occurred from mid-May through July 2017. The breach was discovered on July 29, 2017.



The personally identifiable information (PII) that was accessed includes these details:

- Names
- Social Security numbers
- Birth dates
- Addresses
- Driver's license numbers (in some cases)

What you can do:

- Go to www.equifaxsecurity2017.com to check whether you are one of the 143 million people whose data may have been compromised
- Set fraud alerts
- Monitor credit activity
- Reset account passwords, PIN codes and other log-in credentials on financial accounts that may be vulnerable
- Establish multiple-authentication protocols for financial accounts and email, when possible
- Establish credit monitoring service through Equifax or through other service providers

LISEFCU is here to help you in the wake of this extraordinary and unnerving breach. The incident was limited to Equifax and was not in any way related to LISEFCU, other financial institutions or any direct merchants.

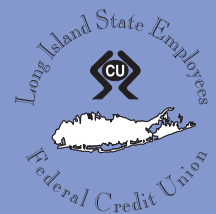

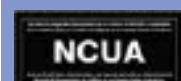
