- The child has to be present at the time of opening the account. The child is the first name on the account and an adult has to be a joint owner.
- The account is a Savings account. No ATM, Debit card, online banking or Mobile APP.
- The minimum to open this account is \$5.00. The minimum to earn 3.00*% is \$5.00.
- Deposit and withdrawals are possible only through shared branching and LISEFCU.
- Only NYS employee's children and grandchildren are eligible for this account.

Pick up your form today and take a vacation from your loan this summer!

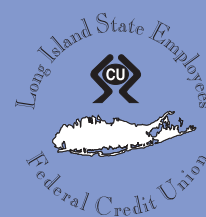
For just \$35 fee per loan you can skip your June, July or August payment!
