Long Island State Employees FCU is presenting college-bound high school seniors with the opportunity to compete for statewide scholarships for either a two – or four year accredited educational institution. It's a simple three-step process, making this an opportunity students can't pass up.

- **Step 1:** Contact our office to request a scholarship application form. If the student is not a member of the credit union, request a membership packet as credit union membership is required.
- **Step 2:** Complete the application form, write an essay and obtain the required transcripts along with the signature of the student's parent or guardian.
- **Step 3:** Return the completed package to the credit union no later than January 27, 2010.

There is no fee for submitting an application, but students applying MUST be:

- Member of credit union
- College-bound high school seniors at the time of application to either a two or four-year accredited educational institution; and
- Attending college for the first time in the fall of 2010.
